FUNCTIONS AND DUTIES OF ANTI-RAGGING SQUAD:

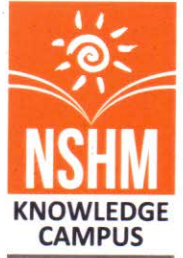
- The members of the squad will visit **at least once in a week** all potential areas of ragging in or outside of the college and hostel premises, including at night and may apprehend the culprits.
